COMMUNITY DEVELOPMENT

ESCROW: Wherever “escrow” is referred to in any Community Development Fee Schedule (except as it relates to ISTS pumping of a holding tank) it shall mean that the applicant shall sign an escrow agreement and pay the required escrow before the project/application request commences. Applicants shall pay the actual costs, regardless of the outcome of the project/application request. Actual costs include all County staff time and any outside consultant costs and printing, copying and mailing costs. County Staff time shall be charged at a rate equivalent to 2.1 times salary to cover fringe benefits, overhead and clerical costs. If at any time the actual costs should exceed the escrowed amount, the applicant shall remit additional funds into the escrow fund when requested by the County. If the applicant fails to replenish the escrow as requested, the County may stop reviewing the application until such time as the escrow is replenished. Any remaining funds in the escrow at the conclusion of the project shall be refunded to the applicant when all actual costs are paid and the County administration of the escrow has been completed.

Time Limitation of Application. An application for a building permit for any proposed work shall be considered abandoned 180 days after the date of filing, unless the application has been pursued in good faith or a permit has been issued; except that the building official is authorized to grant one or more extensions of time for additional periods not exceeding 180 days each. The extension shall be requested in writing and justifiable cause demonstrated. Once a building permit application is accepted and processed by County staff, the applicant, contractor or property owner shall be required to pay a 65% fee of the total building permit fee for plan review services and/or processing services whether or not the permit is issued.

Expiration. Every permit issued shall become invalid and be considered expired unless the work authorized by the permit is commenced within 180 days after its issuance, or if the work authorized by the permit is suspended or abandoned for a period of 180 days after the time the work is commenced. The building official may grant, in writing, one or more extensions of time, for periods not exceeding 180 days each. The extension shall be requested in writing and justifiable cause demonstrated. If the permit has not expired or been invalidated, the applicant, contractor or property owner may only receive a partial refund of the total building permit fee minus expenses for plan review services, inspections and/or processing services. The request for a refund shall be made in writing to the building official prior to its expiration or invalidation. In this case, the building official shall determine if justifiable cause has been demonstrated and determine the refund amount, if any, to be distributed.

Fees shall not be refunded on permits abandoned for over 180 days from the filing date, or on permits that have expired for a period of more than 180 days from date of issuance.

ORDINANCE NO. 2 – SOLID WASTE MANAGEMENT

An application fee will be charged for all major amendments as determined by the Department. Application and License fees are nonrefundable. A \$100.00 late fee will be added to the next annual license fee of any facility or hauler that submits their annual report after January 31st. A \$110.00 fee will be assessed for license and Ordinance violations that result in the need for a reinspection and when a company representative fails to notify the inspector in advance to cancel a scheduled inspection. Bond amounts shall be adjusted annually, as necessary, based on the following criteria: inflation, changes in operation, and changes in the assumptions or standards used to set the original or subsequent bond amount.

F. Additional Permit Related Fees:

1. Property owners who have been referred to the County Attorney's Office for prosecution and charged with failing to replace a failing system may be subject to additional fees requested of the court by the Department to cover administrative costs. In addition, all laboratory and inspection costs incurred shall be billed to the applicant at the time of permit application.
 2. Applications for ISTS permits which lack sufficient soils information for approval (due to weather/seasonal soil conditions) but which the ISTS inspector believes contain sufficient information for conditional issuance of a building construction permit shall be allowed to proceed through the permit process with the condition that final ISTS permit approval will not be granted until complete soil information is submitted and approved. The applicant shall pay an additional fee of \$220.00 to cover the cost of follow-up inspections and review.
 3. The permit fee for an installation commenced before the Department approves the permit for the site shall be double the current permit fee amount.
 4. The applicant shall pay an additional fee equal to 25 percent of the applicable current permit fee when an ISTS/CSTS permit has been issued and the installation has progressed to a point that it can no longer be adequately inspected by the Department because the Department was not given sufficient notice to inspect the system.
 5. The permit fee shall be one and one-half (1.5) times the normal permit fee amount when an applicant requests the Department to approve a permit less than six working days between the dates when the complete application is received and ISTS installation will be commenced (subject to staff availability).
 6. Applicants that request a significant change to an approved permit shall pay an additional fee equal to 25 percent of the applicable current permit fee.
 7. Applicants shall pay an additional fee equal to 50 percent of the permit fee for significant design changes (such as a new site location or system type) when the Department did not approve the change, in writing, prior to the date installation work was commenced.
 8. Permit Refund Policy. Permit fees will be refunded as outlined in a. and b. below minus a 25 percent charge for administration and inspection costs. Additional permit related fees outlined in Section F. are not refundable, such as permit renewal and penalty fees and fees to review design changes and conduct additional inspections.
 - a. When an applicant requests a refund prior to the permit expiration date.
 - b. When an application is received but not approved due to design or site issues.
 9. An ISTS permit is valid for one year after the issuance date. The applicant shall pay an additional fee equal to 25 percent of the applicable current permit fee to renew a permit for one year (50 percent if the permit is renewed for two years). The renewal period begins on the anniversary of the initial issuance date. The permit becomes void three years after the initial issuance date or earlier if the applicant fails to pay an annual renewal fee, as required. The applicant may be subject to additional fees if there are design or location changes from the original permit or if an additional inspection(s) is necessary.
 10. Homeowners (for homes serviced by an ISTS) or developers (for homes to be serviced by a CSTS) shall establish an Escrow account with the Environmental Health Department to pay for pumping costs for holding tanks when a temporary occupancy permit is requested and the ISTS or CSTS is not completed. The fee to administer this Escrow is \$110.00. The amount of the Escrow shall be determined by the following formula:
$$\frac{A \times B \times C \times 75}{D} + E$$
 (Rounded to the nearest \$100.00)

- Where:
- A = the number of days between the date of proposed occupancy and the forthcoming date of September 1.
 - B = the number of proposed occupants in the home plus one (1).
 - C = the estimated cost per pumping specific to that location as determined by a written proposal from a licensed pumper.
 - D = the volume of the holding tanks.
 - E = escrow administration cost.

In addition to the escrow:

For an ISTS, the homeowner shall obtain a signed pumping agreement with an MPCA licensed pumper who shall pump the tank(s) as needed to prevent a discharge or backup into the home and submit invoices to the County for payment on a monthly basis.

For a CSTS, the developer shall obtain a signed pumping agreement (approved by the subordinate service district) with an MPCA Licensed pumper who shall pump the designated tank(s) as needed to prevent discharge or backup and shall submit invoices to the County for payment on a monthly basis.

The escrow shall be replenished by the homeowner or developer as needed until the ISTS or CSTS is completed and operational. Failure to replenish the escrow within 30 days of notification by the County will result in a penalty of 0.25 times the outstanding balance due. Any unused escrow amount minus any penalties shall be refunded to the homeowner/developer after final approval of the permit for the ISTS/CSTS and the County administration of the escrow has been completed. Billable charges against the escrow include invoices from the pumper and County staff time for administration and inspections and follow-up as needed to ensure that pumping is occurring.

Exemption: A subordinate service district that is responsible for temporarily arranging for pumping of septic tanks within the district is exempt from the requirements of Section F. 10 of this fee schedule.

An Inspection fee will be assessed whenever the inspector must conduct an inspection relating to an ISTS or CSTS where the Fee Schedule does not outline a specific fee or when a reinspection is necessary. Examples include Shoreland inspections, meetings with ISTS professionals on site where a permit has not been issued, multiple site inspections to approve the site or during ISTS or CSTS construction, and other requests for site visits.
